Part I Preliminary

Short title

- (1) These Regulations shall be cited as the Animal Health Fees Regulations 2016 and shall come into force on a date as appointed by the Minister by order.
- (2) In these Regulations;

(2) (1) "Act" means that Animal Health Act No. 7 of 2011,

"Authority" means the Guyana Livestock Development Authority,

"Authorised means a person qualified to act as such who has been appointed with the Minister's concurrence by the Authority as an authorised person to carry out functions assigned under the Laws of Guyana,

"Minister" means the Minister of Agriculture,

"Permit" means an import and or in transit permit,

'International means a certificate, issued in conformity with the Regulations Weterinary
Health requirements which are fulfilled by the exported commodities.

Certificate"

(2) (2) Words not defined in these Regulations and its schedules, shall have the same meaning as defined under the Act.

Part II GLDA Services

Application for permit or International Veterinary Health Certificate (3) A person shall upon submission of an application for the grant of a permit and or International Veterinary Health Certificate, irrespective of whether the permit or International Veterinary Health Certificate is granted or not, pay to the Authority fee in respective of that application as established in the First Schedule.

Quarantine Treatment

(4) Where an Authorised Officer makes an order by virtue of the Act or any other law that a terrestrial animal be placed under Quarantine Treatment, fees as stated in Schedule Two shall be paid to the Authority by the person who owns or is in charge of the terrestrial animal prior to its acceptance for quarantine treatment.

Hatchery Services

(5) A person shall upon request for Incubating Services or Supply of Ducklings pay the prescribed fees to the Authority as contained in Schedule Three before the grant of such service.

Laboratory Services

(6) A person shall upon request for Services offered at the Veterinary Diagnostic Laboratory pay the prescribed fees to the Authority as contained in Schedule Four.

Inseminations, Embryo Transfer and Cattle Counts (7) A person shall, upon request for Artificial Insemination, Embryo Transfer and or Cattle Count Services from the Authority pay the prescribed fees to the Authority as contained in Schedule Five.

Part III Refund or Modification to Fees

- (8) 1. Section (8) (1) shall not apply, where a refund of fees is ordered by the Board of Directors of the Authority or the Minister.
 - 2. Fees as contained in the Schedules of this Regulation maybe amended by the Board of Directors of the Authority through public consultation with stakeholders and thereafter sent to the Minister of Agriculture for approval and publication in the Official Gazette.
