The Land Survey (Amendment) Regulations, 2013

In EXERCISE of the powers contained in section *forty* of the Land Survey Act, the following Regulations are hereby made:

- 1. These Regulations may be cited as the Land Survey Title (Amendment) Regulations, 2013 and shall be read as one with the Cap. 188 Land Survey Regulations, in these Regulations referred to as the principal Regulations.
- 2. The principal Regulations are amended by the repeal of the Third Schedule and the substitution therefor of the Third Schedule set out in the Appendix to these Regulations.

SURVEYOR-GENERAL'S CHARGES

1. Land Surveyor's Licence

The fee for the issue of a land surveyor's licence in accordance with section 9 of the Act is 864 fee units. The Surveyor-General may remit this fee for a licence issued to a land surveyor in the service of the Government, but the fee shall become due should the land surveyor leave the Government service and continue to practice in Zambia.

2. Annual Return Practicing Fee

A practicing fee payable by a land surveyor to the Surveyor-General becomes due at the end of each calender year and is 5556 fee units.

3. Examination Fee

For the examination of survey records, general and working plans and diagrams the fee is 389 fee units for each stand, 389 fee units for each lot or farm in urban areas and 556 fee units for each lot or farm outside urban areas.
